4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.

Avoid the generation of dusts during clean-up. Following product recovery, flush area with water.</p> <p>Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.</p>
